## Commentary and Analysis:

Crestwood STEM School demonstrated notable strengths in several key areas. Parental involvement remains exceptionally strong, with an achievement level of 87.3%, earning an *Excellent* rating. Access to supports and services also performed well, achieving 84.2% and assessed as *Good* overall. Additionally, the Citizenship measure was maintained at 78.2%, reflecting a solid performance and rated as *Good*.

Despite these successes, areas requiring improvement were identified. The measure for Welcoming, Caring, Respectful, and Safe Learning Environments declined to 81.5%, resulting in an *Issue* rating. Similarly, Education Quality decreased from 96.3% to 89.4%, now considered *Acceptable*.

To address these concerns, the school will prioritize enhancing students' sense of safety and belonging through restorative practices and increased engagement in STEM-focused initiatives. Furthermore, efforts will focus on strengthening instructional strategies and amplifying student voice to reverse the decline in education quality and ensure a more positive learning experience.

**Commentary and Analysis:** Student learning engagement at Crestwood STEM School currently stands at 82.7%, reflecting a slight decline from previous years. While parent and teacher ratings remain very high and stable, student perception has dropped significantly to 52.7%, which is identified as a concern. Similarly, the Citizenship measure has been maintained overall at 78.2%; however, student responses have fallen sharply to 62.1%, signaling a need for targeted improvement.

To address these challenges, the school will focus on increasing student ownership of learning and fostering a positive school culture. Continued emphasis on STEM programming will support collaboration, critical thinking, and real-world application, helping to re-engage students and strengthen their connection to the learning process.

**Commentary and Analysis:** Citizenship at Crestwood STEM School currently stands at 78.2%, reflecting a slight decline from previous years. While parent and teacher ratings remain very high and stable, student perception has dropped significantly to 62.1%, which is identified as a concern.

To address these challenges, the school will focus on increasing student ownership of learning and fostering a positive school culture. Continued emphasis on STEM programming will support collaboration, critical thinking, and real-world application, helping to re-engage students and strengthen their connection to the learning process. A focus on using Second STEP as a universal program, restorative practice and a variety of leadership and extracurricular opportunities should support growth in these areas. We will focus more intensely on building student awareness and ownership of the school culture and climate.

- Commentary and Analysis:** Education Quality remains a strength overall but has declined from 96.3% to 89.4%, with student voice showing a significant drop to 79.8%, marked as a concern. While teacher and parent ratings remain strong, the decline in student perception highlights the need for improvement. The school will focus on refining instructional practices in STEM, literacy, and numeracy, while promoting strategies that empower students to articulate their understanding and engage meaningfully in their learning journey.

Strengthening partnerships with families will remain a priority to ensure collaborative decision-making and shared responsibility for student success.
